SECTION 4: First-Aid Measures

#### 4.1. Description of first aid measures

Our products are destined to intermediate users and distributors, farmers to use in their agricultural activities or to people working in horticulture, green houses cultures, parks protection, gardening or sports' field maintenance, silviculture and

other similar activities.
