SECTION 4: First-Aid Measures

4.1. Description of first aid measures

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

Content ammonium nitrate. We don't commercialize products whose weight contains more than 28% of nitrogen compared to ammonium nitrate. We use it as a solid fertilizer, it is a much simpler composite, respecting the 3rd Annex of the EU Regulation of 2003/2003. As well, we don't commercialize products whose weight contains 16% or more of nitrogen compared to ammonium nitrate. Our products are destined to intermediate users and distributors, farmers to use in their agricultural activities or to people working in horticulture, green houses cultures, parks protection, gardening or sports' field maintenance, silviculture and other similar activities.

Shall not be used in: ornamental articles intended to produce light or colour effects by means of different phases, for example in ornamental lamps and ashtrays, tricks and jokes, games for one or more participants, or any article intended to be used as such, even with ornamental aspects.

Regulation (EU) 2019/1148 on the marketing and use of explosives precursors:

Contains ammonium nitrate. Product under the provisions of Article 9. However, products that contain explosives precursors only to such a small extent and in such complex mixtures that the extraction of the explosives precursors is technically extremely difficult should be excluded from the scope of this Regulation.

Specific provisions in terms of protecting people or the environment:
